7th Year

As we step into 7th year, we as an organisation have learnt and matured in many ways in the journey to Inclusion. We have grown and started our new branch in IIM Calcutta Innovation Park, Joka, Kolkata to cater the Northeast region of India. With the experience over the years, we have taken up projects on Health, Livelihood, Education and have successfully implemented with more knowledge. This is possible with the support of all the NGOs, Corporates, and Volunteers who have believed in our vision from the start.

PROJECT: LIVELIHOOD

Swatantra - The Freedom

A program for skilling Persons with Disabilities and the underprivileged. Aim is to build long term varied skill sets of NGO partners so that they can tap into open market to sell their products. The main goal of this program is to enhance the quality of life of Persons with Disabilities and their caretakers through increased knowledge and skills but merely imparting literacy will not be sufficient. They need vocational training or skills as well to uplift their status. They should be able to stand on their feet and be an earning member of the family.

Banana Weaving Project

COIMBATORE

This Pilot Project was conducted in 2 Months identifying 2 Women and 1 Person with Hearing Impairment. This project covered a week of training on understanding the weaving machine and basic techniques of weaving.



Bag Production Unit



BAGALKOT

This Project started with identifying 18 Women with disability from rural Bagalkot, we set up the unit with high end machinery, conducted Train the trainer activity for a month and started the training for Women with Disabilities. This project covered all the basics on stitching of a bag, understanding the technicalities of the machine, knowledge on the quality maintenance and sourcing of materials.

Impact Stories

"Madhivanan a person with hearing impairment on the loom. Activity is being done slowly, as he is quite careful. He has never gone to school, and this was his first job. One could see the interest him completely indulged in the process of weaving" said trainer.



15 People with Disability has learnt the skill of bag stitching and they like to continue running the production unit by marketing and identifying new orders. GiftAble would be supporting the group empowering them further on business management skills and also providing them orders.

PROJECT: HEALTH

Early Intervention

Our Early Intervention Program that is dedicated to helping children between the ages of 0- 6 years who have a developmental delay in 5 core areas.

1. Cognitive Development
2. Physical Development
3. Communication Development
4. Social and emotional Development
5. Adaptive Development

Aim of this program is to promote age-appropriate development and growth of children with developmental delay.

Students were super excited as they played chess before but were touching, feeling & playing ludo, rubik cubes, tic tac toes & sensory cards for the first time. They learnt it so fast & started winning games. Thank you volunteers who made this happen.

Wall of Hope

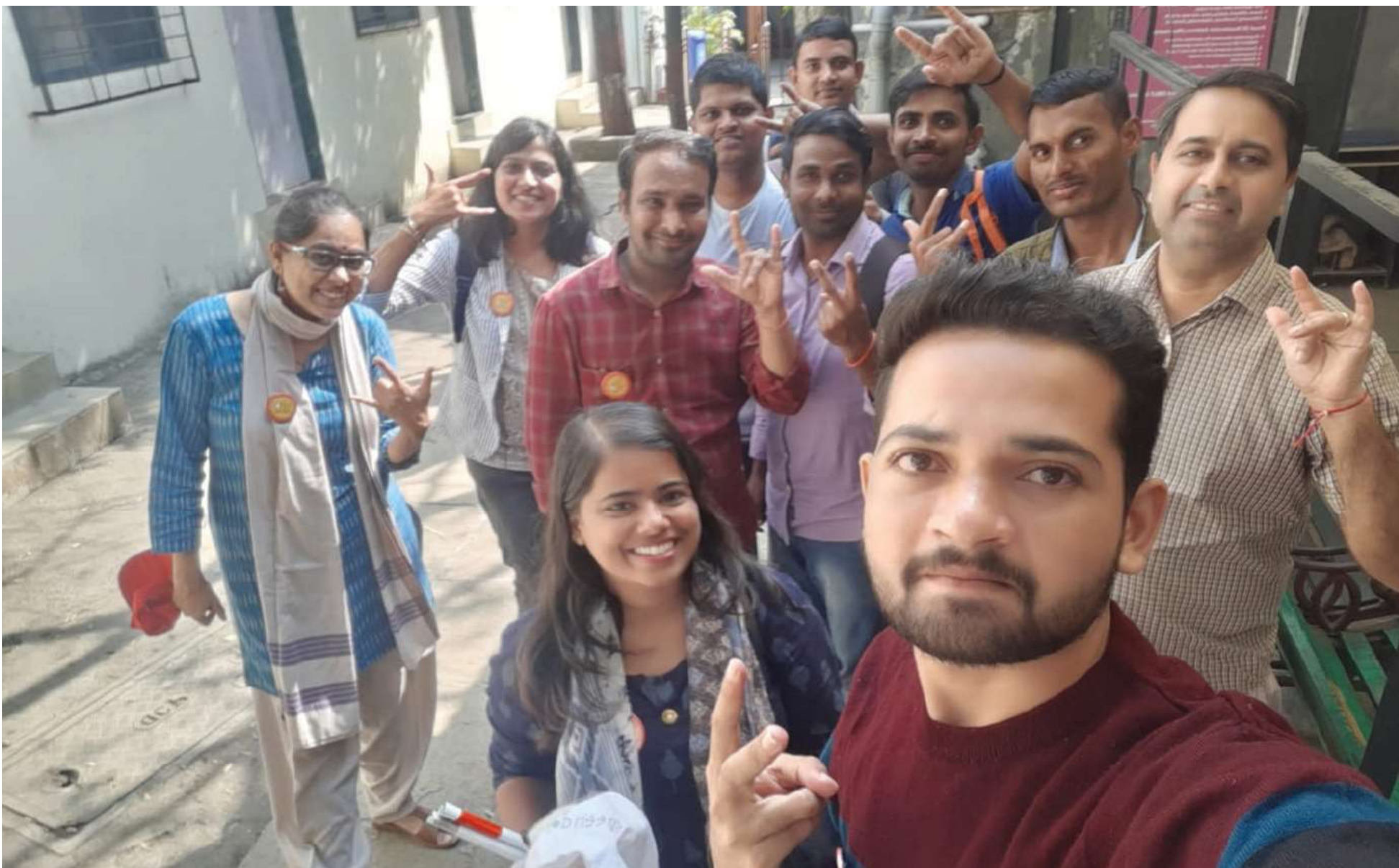
